However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

**BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF ..... \$ 3,395.00**  
 24 hour availability of staff to respond to the initial request for service; consultation and arrangements with family, clergy, cemetery or crematory and others as required; preparation, filing and securing of necessary notices, authorizations and permits; assistance with forms and print notices and basic overhead such as insurances and secretarial, administrative, and maintenance costs. This fee for basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charge for direct cremations, immediate burials and forwarding and receiving of remains.)

**EMBALMING ..... \$ 515.00**  
 Except in certain special cases embalming is ***not required*** by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral service with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for embalming, such as direct cremation or immediate burial. (This funeral home requires embalming for all services having public viewing.)

**OTHER PREPARATION OF THE BODY ..... \$295.00**  
 This service includes many of the following items, but is not limited to such as: bathing, dressing, casketing, restorative art, and any other preparation needed to secure human remains in a safe and appropriate manner.

Our charge for an immediate burial, without any attendant rites or ceremonies, includes removal and shelter of remains, local transportation to cemetery, and necessary services of staff. This service does not include embalming or any other use of facilities.

IMMEDIATE BURIAL with casket provided by purchaser..... **\$ 2,195.00**

### DIRECT CREMATION \$2,195.00

Our charge for direct cremation without any attendant rites or ceremonies includes removal and shelter of remains, transportation to local crematory, crematory fee, alternate container, burial/transit permit, Medical Examiner permit and necessary services of staff. This service does not include embalming or any other use of facilities. If you want to arrange for a direct cremation, you can use an alternate container. Alternate containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The alternate container we provide is a cardboard box with a plywood or chipboard base. Paid death notices and certified copies of death certificate are considered additional cash advance items and are not included in the price of direct cremation.

### FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME ..... **\$2,195.00**

This charge includes local removal of remains, services of staff, embalming, receptacle for body, and necessary authorizations. This charge does not include additional mileage, the services of staff or the use of facilities for any public visitation and/or funeral rites or ceremonies prior to forwarding of the body.

### RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME ..... **\$2,195.00**

This charge includes shelter of embalmed remains, transportation of remains to local cemetery and required services of staff. It does not include the mileage, service of staff or the use of facilities for public viewing and/or funeral rites/ceremonies after receipt of remains.

The only warranties, expressed or implied, granted in connection with goods sold with this funeral service are the expressed written warranties, if any, extended by the manufacturer thereof; and no warranties of merchandising fitness for a particular product are extended by the seller. In most areas of the country, no state or local law makes you buy a container to surround the casket in the grave. However, many cemeteries ask that you have such a container so that the grave will not sink in. Either a burial vault or a grave liner will satisfy these requirements.
